## **Vulcan Naval Reactor Test Establishment (NRTE)**

The majority of sites inspected by ONR are licensed under the Nuclear Installations Act 1965 (as amended). Vulcan NRTE is not a licensed site although it operates under Authorisation from the Ministry of Defence (MoD) Defence Nuclear Safety Regulator (DNSR). The site is adjacent to the Dounreay licensed site and is regulated by ONR through other legislation as noted below. This report summarises ONR inspection and other regulatory activities associated with Vulcan NRTE which are co-ordinated with inspections by DNSR.

### **1 INSPECTIONS**

#### **1.1 Dates of inspection**

During this period no on-site inspections were undertaken by ONR. However, ONR inspectors attended meetings to discuss arrangements for future emergency exercise demonstrations.

### **2 ROUTINE MATTERS**

#### **2.1 Inspections**

Inspections are undertaken as part of the process for monitoring compliance with the Health and Safety at Work Act 1974 (HSWA74); and regulations made under HSWA74, for example the Ionising Radiations Regulations 1999 (IRR99), the Radiation (Emergency Preparedness and Public Information) Regulations 2001 (REPPiR), and the Management of Health and Safety at Work Regulations 1999 (MHSWR99).

No on-site inspections were undertaken during this quarter.

#### **2.2 Other work**

The ONR Site Inspector and an ONR Emergency Preparedness and Response specialist inspector attended meetings with Vulcan NRTE, Highland Council and Dounreay Sites Restoration Limited to provide input to planning for future emergency exercise demonstrations.

### **3 NON-ROUTINE MATTERS**

Licensees are required to have arrangements to respond to non-routine matters and events. ONR inspectors judge the adequacy of the licensee's response, including actions taken to implement any necessary improvements.

There were no such matters or events of significance during the period.

### **4 REGULATORY ACTIVITY**

ONR inspectors may issue formal documents to ensure compliance with regulatory requirements. No such documents were issued during this period.
