



# Office for Nuclear Regulation (ONR) Quarterly Site Report for Winfrith

## 1 INSPECTIONS

### 1.1 Dates of inspection

The ONR site inspector attended meetings with Winfrith on the following dates:

- 4 February 2016 – Winfrith End State

ONR inspectors attended a meeting arranged by the licensee to discuss Winfrith End State. This meeting was also attended by the Environment Agency, the NDA and Dorset County Council. The meeting discussed the possible final condition of the site and how this may be regulated.

- 26 February 2016 - Emergency Arrangements Revision

The ONR inspector met with the licensee to discuss the licensee's proposal to revise its emergency arrangements

ONR held a meeting with Inutec Ltd on the following dates during the quarter:

- 1 March 2016 – Application for a Nuclear Site Licence

## 2 ROUTINE MATTERS

### 2.1 Inspections

Inspections are undertaken as part of the process for monitoring compliance with:

- the conditions attached by ONR to the nuclear site licence granted under the Nuclear Installations Act 1965 (NIA65) (as amended);
- the Energy Act 2013
- the Health and Safety at Work Act 1974 (HSWA74); and
- regulations made under HSWA74, for example the Ionising Radiations Regulations 1999 (IRR99) and the Management of Health and Safety at Work Regulations 1999 (MHSWR99).

The inspections entail monitoring licensee's actions on the site in relation to incidents, operations, maintenance, projects, modifications, safety case changes and any other matters that may affect safety. The licensee is required to make and implement adequate arrangements under the conditions attached to the licence in order to ensure legal compliance. Inspections seek to judge both the adequacy of these arrangements and their implementation.

In general, ONR judged the arrangements made and implemented by the site in response to safety requirements to be adequate in the areas inspected. However, where improvements were considered necessary, the licensee made satisfactory commitments to address the issues, and the site inspector will monitor progress during future visits. Where necessary, ONR will take formal regulatory enforcement action to ensure that appropriate remedial measures are implemented to reasonably practicable timescales.

ONR currently considers Winfrith to be a low nuclear hazard site and as a consequence, its compliance inspection policy for this site requires four interventions per year. Whilst no inspections have been carried out this quarter, the site inspector's interventions are on plan.

Magnox has informed ONR that it intends to revise its emergency arrangements for Winfrith. It has requested ONR approval of a proposed emergency plan. ONR has commenced its assessment of these proposed emergency arrangements.

## 2.2 Other work

The nuclear safety site inspector attended a regulatory meeting with the Environment Agency site inspector. This meeting provided an opportunity to monitor and influence the progress and outcomes of the site's decommissioning programme and share information with the EA counterpart.

## 3 NON-ROUTINE MATTERS

Licensees are required to have arrangements to respond to non-routine matters and events. ONR inspectors judge the adequacy of the licensee's response, including actions taken to implement any necessary improvements.

In this period the following incidents on the site were reported to ONR:

- ONR was notified that elevated gamma radiation levels was found whilst monitoring an area on the Winfrith site.
- ONR was notified of an employee who fractured a toe by dropping a herras fence foot.

ONR is satisfied that the licensee responded to this incident appropriately for both events, and no enforcement is considered necessary.

## 4 REGULATORY ACTIVITY

ONR may issue formal documents to ensure compliance with regulatory requirements. Under nuclear site licence conditions, ONR issues regulatory documents, which either permit an activity or require some form of action to be taken; these are usually collectively termed 'Licence Instruments' (LIs), but can take other forms. In addition, inspectors may issue Enforcement Notices to secure improvements to safety.

No LIs or Enforcement Notices were issued during the period.

## 5 NEWS FROM ONR

### Chief Nuclear Inspector appointment

ONR announced the appointment of Dr Richard Savage as its new Chief Nuclear Inspector (CNI) to lead our regulatory activity. Richard is a Chartered Engineer with an extensive background in nuclear safety and regulation. He served as Head of the Defence Nuclear Safety Regulator, Ministry of Defence, before being appointed to ONR as a Deputy Chief Nuclear Inspector in 2013. He was Acting CNI since Dr Andy Hall's retirement in November 2015.

### ONR Strategic Plan 2016-2020

In March, ONR published its Strategic Plan covering 2016-2020. The plan sets out the factors that will influence our work and the assumptions we have made about regulating the nuclear sector in the next few years, as well as how we deliver the commitments we have made to the public, ministers and government, licensees, dutyholders and our staff. The plan was laid in Parliament on 22 March and can be viewed on the ONR website.
