Hi

I have sent an email to AWE today to say I am minded to continue with my

assessment at the preapp stage.

This is based on:

- a review of the current application
- a review of what I said then and any changes - no
- the review I did at preapp stage involved a number of agencies who were consulted and agreed with my proposal.
- a long discussion with the regulators

I have given AWE until noon to let me know anything significant I may have missed.

If I hear nothing then please can you submit my response as:

*Emergency Planning at the Council, and other stake holders at the time of the preapp, have reviewed this proposal and have no adverse comments.*

*This is based on a number of factors since the proposal site is within the DEPZ for AWE Burghfield and it would be an increase in the population within the overall DEPZ.*

*However, based on the distance from the AWE site, which on its own is not a reason for no adverse comments but this combined with the scant population in the surrounding area for some distance and that the construction is detailed to be of a robust nature of the buildings all of which means that the impact on the AWE Off-Site Emergency Plan is assessed to be low.*

*It should be noted however this is an exceptional case and it is not without a request for conditions to be included should the application be approved including:*

*A condition to include a landline to each of the properties in order that the AWE Alerting System which involves landlines can be operational  
A condition in relation to the construction phase such that no construction/demolition on site shall commence without a robust emergency planning being submitted to the LPA for approval. Reason to ensure the health and safety of the construction workers should there be a radiation emergency during that phase.*

clarify anything.
